Background Information

- **EIR** are electronic and information resources, a broad term which encompasses hardware, software, websites, subscription databases, printers and faxes, etc. If it's Information Technology and it has a user interface, it's an EIR.
- Texas state law requires that all our EIRs are **accessible** i.e. that they can be used by all people, including those with disabilities.
- If the EIRs are not fully accessible, and very few are, then Texas law requires us to process an **accessibility exception**.
- The exception request must be reviewed and approved by a number of people e.g., department head, EIR Accessibility Coordinator, CIO and designated signer.
- TAMUC uses a form called Laserfiche to route the complete exception form to all the right approvers. Below are the instructions on how to access and fill out the form.

Laserfiche Instructions

O. Once the exception has been submitted, it will route to the Department Head for approval. From there your exception request will go to the ISO, the EIRAC, the CIO and finally the designated signer for approval. You will receive emails at each approval step.

Approvers: Approving EIR Accessibility Exception Requests

Once the exception request has been submitted by the requestor, the form will be routed to the department head. The department head will receive an email notification to review the exception request.

- c. Department Head: Clicks on hyperlink task.

 - a. If approved the record immediately goes to the EIR Accessibility Coordinator to review the form. Upon approval the form will then be routed to the CIO then the designated signer, respectively to review.
 - i. If the EIR form is rejected, the form will notify the requestor and EIR Accessibility Coordinator.
